**Welcome** (Margaret Briggs, President) Margaret called the meeting to order at 7:04 pm, welcomed the MAFA Reps with the following comments:

I am so happy to be continuing on the MAFA board, though in a new role as president. It's been an exciting past two years -- maybe a little too exciting sometimes -- but we are all looking forward to what we can accomplish in the next two years. We started conversations about diversity and inclusiveness, and that work will continue and hopefully grow under the guidance of our past president, Helena Valentine, because it's important to engage all who are interested in fiber arts.

Who would have thought a global pandemic would help strengthen our organization and bring all our members together in new ways. But that's exactly what it did. For a start, Zoom meetings. I know, Zoom meetings. But they allowed us to continue meeting as guilds, to bring far-flung members back into the fold, to attend programs and take classes anywhere in the world. For MAFA, we started the guild Roundtable series, that we plan to continue and expand going into next year, with programs for all members. And, most importantly, video conferencing allowed us to have a conference anyway.

Our biggest takeaway from that virtual conference was the ability we found to engage MAFA members across our entire geographic area, many of whom can't attend in-person conferences. Now we want to keep all our members connected, and my goals as president include exploring ways we can keep that engagement, offer programs beyond just the conference, and expand our outreach efforts - both on our own, and through guild grants.

**Minutes** (Patty Chrisman, Secretary) The minutes of the Reps meeting and election of July 27, 2021, were approved as published upon motion by Dave Banks; second by Karen Miller.

**Treasurer's Report** (Liz Heine, Treasurer) Liz submitted the following report: Balances as of September 30, 2021:

Liz noted that we are starting our financial review with an auditor and that it should be completed by mid-December.

2021 Conference Report (Margaret Briggs, President) Margaret submitted the following report:

# <u>Budget</u>

All income and expenses have been addressed and we can report Conference 2021 net income of \$61,410. This includes that Cvent waived a \$8,750 video overage fee. This far exceeded our expectations and will provide breathing room for other MAFA activities in the future.

# Surveys

The Conference survey received 267 results and comments were overwhelmingly positive. That feedback will be used by the 2023 Conference Committee to consider whether or how to incorporate virtual activities with the in-person conference, and we will also look at scheduling virtual programs at other times for MAFA members who may not be able to attend conferences.

**2023 Conference Report (2<sup>nd</sup> VP Conference, Carol Steuer)** Carol reported that she will be announcing a "kick-off" meeting for the 2023 Conference Committee soon. She noted that the first task will be to compile a list of potential instructors (suggestions welcome) and to send out RFPs to these instructors. Volunteers for the Conference Committee are welcome.

Membership Report (Sara Robbins, Membership Chair) Sara reported the following:

- Member guilds: 54
- Associate members: 225

The next Roundtable will be November 23, 2021, when Frances Irwin Handweavers will present their MAFA grant funded project "Linen: the Journey from Seed to Cloth." This Roundtable is open to ALL members.

**Grants and Fellowships** Secretary Patty Chrisman gave the report on behalf of Angela Fishman, Grants Chair:

Do you have a great idea on moving forward now that we may be seeing the end of the pandemic? Please consider submitting a grant proposal to MAFA. The early decision deadline is November 1, 2021, for those of you who want to be up and running in 2022. The regular deadline is January 10, 2022, for those of you not in a big hurry. Please see the guidelines on the MAFA page under the Grants Tab.

If you have questions or want to run an idea past us, feel free to send an email to grants@mafafiber.org. Even small grants are welcome.

With a new year upon us we have some vacancies on the grants committee. If you have an interest, or know someone who does, we could use representation from all the states other than PA and NY (already represented). The terms are two years, and the grant evaluations are generally early in the year. It's a great way to get to know how other guilds and groups are doing in their communities. Website Report (Dave Banks, Webmaster) Dave reported that several guilds would like to set up websites with MAFA support. That is keeping him busy.

## **New Business**

• Discussion of proposed dues for 2022-2024. Proposed realignment of membership tiers, and should we continue the option to pay half dues.

President Margaret Briggs submitted the following proposal for discussion:

## MAFA Proposed Dues 2022-2024

This is an issue that goes back to my time as Membership Chair, then the issue was tabled due to the pandemic. What I observed is that we have several small and mid-sized guilds paying a disproportionate share of the dues. Meanwhile, since the top tier of membership is for guilds with 101 or more members, the very large guilds pay the same as guilds half their size.

Since 2022 will be a renewal year, we want to start a discussion with the reps about revising the membership tiers so that there is time to review this with your guild board. There is also the question of continuing an option for 50% dues. Then we will vote on adopting dues for 2022-2024 at the May Reps Assembly so the renewal process can start in late summer.

First, we propose adding two tiers of very large guilds. Then we started figuring dues with the idea of a per capita dues amount of \$1.50 per guild member. Since administering every guild having difference dues based on number of members as of a particular date was going to be confusing, we calculated a rough average for the tiers of guild sizes to arrive at a proposed amount for each tier—with the following result:

- The smallest guilds dues go down slightly.
- Mid-size guilds dues remain the same.
- Large guilds dues go up because they are in a new tier.

Proposed dues tiers are:

- 25 or fewer members: \$50 (*was* \$60)
- 26 50 members: \$70 (*was* \$70)
- 51 100 members: \$100 (was \$100)
- 101 150 members: \$150 (was \$150 but tier now caps at 150)
- 151 200 members: \$200 (was \$150 in the old 101+ tier)
- 201 or more members: \$250 (*was \$150 in the old 101+ tier*)

There would be no change to dues for Associate members which will remain at \$40.

There was discussion regarding the above proposal as well as the proposal to offer the option to pay half dues to guilds who are still struggling due to the pandemic. Knowing that guild membership can be in flux during the year, the proper dues tier should be based on the number of guild members at the time of renewal. The time frame for dues is two years, therefore the notice of renewal will go out in August 2022.

Examples of how various guilds fared during the past two years were discussed, with some expanding membership while others had a decline in guild members. For a number of guilds, dues are the primary revenue. One guild noted that their budget was impacted as they provided increased programming online. Additionally, many guilds were not able to hold sales—a major source of revenue for some guilds.

Concern that reducing dues might negatively impact MAFA was mentioned, however Margaret Briggs noted that dues are less than 25% of MAFA income, and the success of recent conferences has given us a strong base.
