2023 Conference Final Report (Margaret Briggs, Acting Conference Chair)

As reported in July, the MAFA 2023 in-person event was successful. Given that this was our first in-person event after the pandemic, and with all the uncertainty that entailed, we approved an overall MAFA budget with a significant loss of \$15,000 - \$18,000, or in other words, the board approved putting some of the MAFA nest egg to work to keep registration costs down. The fact that we successfully presented the 2023 conference with a much smaller loss than anticipated is a big win. At the end of the fiscal year on September 30, 2023, our net income from the conference was -\$1,885. Higher enrollment was a major factor.

2025 Conference Kickoff Report (Margaret Briggs, Acting Conference Chair)

MAFA 2025 will be held June 26-29, 2025, at Millersville University. The Conference Committee had its first planning meeting last week, and we're very happy that many of our experienced coordinators are back. We also look forward to bringing some new faces onto the committee.

For 2025, we particularly need volunteers for the following important roles. - Ads and Donations Coordinator contacts advertisers and organizations and manages submitted ads and donations.
- **Volunteer Coordinator** coordinates and manages volunteers before the conference and onsite
- Weekend Classes Coordinator solicits, schedules, and coordinates up to a dozen 2 to 3 hour classes for day trippers on Friday afternoon and Saturday during the conference.
- Goody Bags Coordinator collects and sorts goodies donated by guilds so they are ready to stuff in the conference totes. [NOTE since the meeting, we have a volunteer for Goody Bags.]

MAFA Virtual Report (Margaret Briggs, Virtual Chair)

Since beginning in September 2022, the MAFA Virtual program has been very successful. We held 19 classes between September and May, 6 free lectures, and we offered the two-day "Mini" virtual conference. At the end of the fiscal year on September 30th, our net income from all virtual programs was over \$16,000. That income will cover the cost of free lectures and low enrollment classes in the future.

Virtual events resumed in September. The first two classes were scheduled for October and November, and we expect to offer more classes January through June 2024. Classes will be posted at lessonface.com/mafa as we get them scheduled.

MAFA Free Lectures will continue with four to six lectures per year. We have two lectures scheduled for this Fall - one was in September and the next will be "Craft Activism, Memory-Making, and Political Action" with Hinda Mandell, on November 28th. Patty Chrisman will organize lectures for 2024. Lecture registration is also on Lessonface.

MAFA Movie Nights continue on second Wednesdays, and attendance has been very good, ranging from 25 to over 100 attendees. Find details and links to previous videos on the MAFA website Virtual tab, or email Kate Ohara at movies@mafafiber.org.

The current tentative plan is to schedule another MAFA Mini for 2025.

We are looking for a Virtual Committee Chair or co-chair. The chair is an appointed board position, and responsibilities include: managing the overall schedule and budget, soliciting and scheduling classes, coordination with Lessonface to post classes and follow up on registration, coordination of moderators, and helping do all of this for the Mini. A new chair needs to be
